

VQEG meeting @ San Mateo - June 26-30, 2023

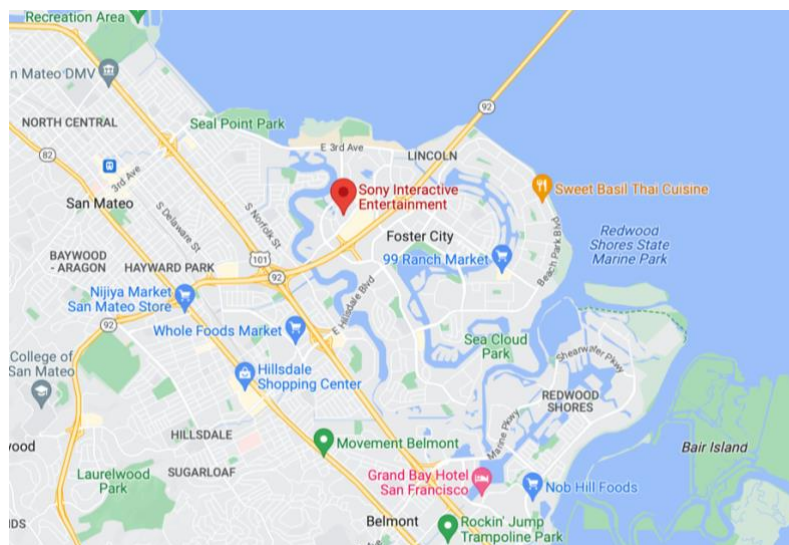

VISITOR CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT

This VISITOR CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT, effective March 31, 2023, ("Effective Date"), is between Sony Interactive Entertainment LLC, a California limited liability company (referred to as "we," "our," or "us" in this agreement), and you, whose name and signature appear below. This agreement starts on the Effective Date and continues as long as we keep the Confidential Information confidential.

We grant you access to SIE's premises ("Campus") to participate in meetings, discussions or presentations, to perform work or for some other limited purpose and, in exchange, you are bound by this agreement's terms.

Confidential information means all information disclosed to you or that you are exposed to while on Campus, including any documents, conversations, or anything you may see or hear while on Campus ("Confidential Information"). All Confidential Information remains our property. Confidential Information does not include information that: (i) is currently or legitimately known by the public; (ii) we publicly disclose; or (iii) you already knew about.

You shall: (i) hold Confidential Information in strict confidence; (ii) not disclose what you heard or saw on Campus to any third party without our written approval; (iii) not interfere with our ownership of any Confidential Information (meaning that you will not file for patents, trademarks or purchase website domain names related in any way to the Confidential Information); and (iv) upon our request, immediately return to us any Confidential Information in your possession.

If you disclose any Confidential Information without our approval, this could cause SIE irreparable harm for which money damages would be insufficient, and we will be entitled to injunctive relief in court. This agreement is governed by and construed in accordance with California law. Any action or proceeding related to this agreement must be brought in the Superior Court of the County of San Mateo, State of California or the United States District Court for the Northern District of California.

This Visitor Confidentiality and Non-Disclosure agreement constitutes the entire agreement between us and you relating to its subject matter. No waiver or modification of any of the terms of this agreement is effective unless in writing and signed by the party against whom the waiver or modifications would be enforced.

YOU HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. YOU ARE AWARE THAT THIS IS A CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT BETWEEN YOU AND SIE AND SIGN IT OF YOUR OWN FREE WILL.

Remote access: The meeting will be streamed through MS Teams. The links to the meeting will be sent to those registered before the meeting.
